Greetings to our Siblings in Christ,

I wanted to take some time to provide an introduction to St. John's Lutheran Church's 2021 Annual Congregation Report. It has been an extremely unusual year, where we have addressed many problems as we try to continue our mission and support our communities during this sustained pandemic.

At a top view, a lot happened in 2021, so let's review a few important milestones.

- We said an earlier-than-expected "farewell" to our interim Pastor, Joan Armstrong for medical reasons. I wanted to personally thank Pastor Armstrong from my heart for all she did to help us during our bounce-back from being closed throughout most of 2020. We'll miss you!
- Our call committee has completed our pastoral call paperwork with the Southern Ohio Synod, and our search for a permanent part time pastor is on. This could take a while, and while it may be possible we'll get another short term interim, it is most likely we will be using supply pastors for the foreseeable future simply because of availability. As our search widens, we will update the congregation on our progress.
- We returned to in-person worship for Easter 2021, and have held fast even as the pandemic "Omicron variant" surge reared its ugly head. This is a testament to our Congregants, our staff, and our interim Pastors who continue to provide a high quality worship experience for both in person and virtual attendees. Speaking of virtual, we also applied for and executed a \$500 cost sharing grant with the Southern Ohio Synod to upgrade to High Definition Cameras and computers, so our virtual livestream is of excellent quality.
- We allowed additional outside groups to return to St Johns, which includes at least
 4 or 5 Girl Scout Troops in addition to our substance abuse group missions.
- We executed a successful "public shred and bread" event in October which generated an additional \$1,000 for helping hands and took many cubic feet of document shreds off of our community hands.

- We're close to paying off our repaired Fellowship Hall roof, installed in May of 2020. We took out a 10 year loan against our endowment, and expect to retire that debt by this coming Spring at current giving levels, over 7 years early. This is especially important, because if we have another capital need in the future, we can pursue this path again once this roof loan is paid off. (That is, for instance, if we had to replace a major failed system, like our 30+ year old HVAC systems in the fellowship hall).
- Financial support for the Congregation has been outstanding, and we'll finish the year with a small surplus, which our Treasurer will discuss.
- Finally our Christian Education and Sunday School have operated and grown even in the face of the pandemic. This is a direct result of the dedication of our Learning Committee Team members, and I want to especially cite this team for their excellence and dedication. I especially appreciate your "5th youth Sunday" services, a distinct characteristic of St Johns!
- My thanks as well to our lay assistants, musicians, and alter guild that all make our weekly services smooth and meaningful.
- Lastly, we bid farewell to Mr. Don Pabst from Council having termed out in 2021.
 THANK YOU Don for your service, as well as our one year officers (Judy Kuemmel
 Financial Secretary, Linda Kent Treasurer, and Cathy Zimmer, Council
 Recording Secretary). I'm optimistic they'll sign up for another term, but we still
 greatly appreciate their service.

So, that's the year in a nutshell. I certainly didn't expect the twists and turns of 2021, but with your support the Congregation remains strong. That, friends, is a measure of your commitment to the mission of grace, and forgiveness that is our Lutheran Faith. God Bless you all.
